Our publishing date has slipped to late summer/early autumn. As we promised before, we can certainly brief the Tribe on the contents of the final rule after it has been signed by the Administrator. As with all comments, we thoroughly evaluated the Tribe's comments, and our responses will be contained in the Response to Comments document that will be released the same day as the final rule. Regarding radon monitoring at tailings impoundments, recall that we proposed to eliminate the monitoring for impoundments in existence prior to December 15, 1989. We received many comments on this issue, and it will be discussed in the final rule.
