

This is Mike Lidgard acting office director for the Office of Water and Watershed EPA Region 10. This is September 11, 6:15 pm in Idaho Falls. We were present at 6:00 p.m. this evening to conduct a public hearing on the IPDES program submittal and review by EPA. No one attended the hearing nobody selected to give oral testimony; therefore, we are closing the hearing at 6:15 p.m. EPA did conduct a





public meeting on this topic beginning at 4:00 p.m. this evening, which was well attended. That session closed at 5:30 p.m. Thank you.

My name is Mike Lidgard, I am the Acting Director for the Office of Water and Watersheds with the U.S. Environmental Protection Agency Region 10, in Seattle Washington. I am the Presiding Officer for tonight's hearing.

With me tonight is Karen Burgess, who is the Acting Manager for the EPA Region 10 NPDES permit program and is the team lead for the EPA group that has been reviewing the State's application.


I would also like to introduce Mary Anne Nelson, Manager of the State's IPDES Permit Program.

Karen and Mary Anne led our public education meeting this afternoon on this topic and will also be available for any questions after the conclusion of the hearing.

Before we begin to hear public testimony for the record, I would first like to briefly describe the action that EPA is taking comment on here tonight. I would also like to describe the schedule associated with this action. This information is also provided in the handout in the front of the room. Following this overview, we will begin taking public testimony.

Section 402 of the CWA created the NPDES program under which EPA may issue permits for the point source discharge of pollutants to waters of the United States under conditions required by the Act. Section 402 also provides that EPA may approve a State to administer an equivalent state program, upon the Governor's request, provided the State has appropriate legal authority and a program sufficient to meet the Act's requirements. To date, 46 states have been authorized by EPA to administer the permit program.

By letter of August 31, 2016, the Governor of Idaho requested NPDES program approval and submitted an application that includes a program description, an Attorney General's statement, copies of applicable State statutes and regulations, and a Memorandum of Agreement to be executed by the Regional Administrator of EPA Region 10 and the Director of IDEQ. EPA Region 10 determined that the





state's program application received on August 31, 2016 constitute a complete package under federal regulation. A letter of completeness was sent to the Director of IDEQ on September 30, 2016.

The State of Idaho is applying to administer the NPDES permitting, compliance and enforcement programs for individual and general permits, as well as for the pretreatment, biosolids, and stormwater programs in the State of Idaho.

Pursuant to federal permit regulations, the EPA must approve or disapprove a submitted program (which has been determined to be complete) within 90 days of receipt, unless this review period is extended by mutual EPA-State agreement. EPA and the State have mutually agreed to extend the approval or disapproval decision to July 1, 2018.


The State of Idaho has asked to assume responsibility for the NPDES programs in phases, pursuant to the CWA section 402(n)(4). Idaho's application appears to meet the requirements for such a phased approach.

IDEQ will assume permitting and compliance authority for the NPDES program in four phases. The EPA will retain full permitting and compliance authority over facilities until that authority is transferred to IDEQ in accordance with the following schedule:

- Phase I Authority for individual municipal permits and pretreatment programs shall transfer upon gaining program approval projected for July 1, 2018
- Phase II Individual industrial permits, one year after program approval
- Phase III General permits, with the exception of stormwater two years after program approval permits. And finally,
- Phase IV Federal facilities, general and individual stormwater permits and biosolids, three years after program approval

EPA is accepting comments from the public on the State's request for NPDES program approval through October 10, 2017. Directions for submitting written comments are included in the handout in the front of the room and on EPA's website. After considering all public comments provided during the public comment period and from the public hearings, and after completion of required consultations, the Administrator for EPA will make a decision to approve or disapprove the IPDES program based on the requirements of Section 402 of the CWA and federal regulations. If the Administrator approves the Idaho program, the Administrator will so notify the State. Notice would be published in the Federal Register and, as of the date of program approval, EPA would suspend issuance of NPDES permits in Idaho in accordance with the State's approved schedule to transfer NPDES program authority as described in the State's phasing plan. If the Administrator disapproves the states program, IDEQ will be notified of the reasons for disapproval and of any revisions or modifications to the program that are necessary to obtain approval.



At this point we have two people signed up to speak. So first, I would like to invite Scott McClury to come forward.

Speaker, Scott McClury

Thank you, Mike. Yeah, my name is Scott McClury and I live at 222 W. 500 S. in Jerome. I grew up on a farm a 351 W. 300 S. in Jerome and was there went away for a few years in the Marine Corp one thing or another, then came back and for about 30 years living in that area.

Number one, I appreciate this forum. It has been very informative and filled in a lot of gaps I had in my understanding of the situation so I very much appreciate that. You know my comments first, far as, regarding whether authority should be transferred from EPA to Idaho Department of Environmental Quality, I have no problem with that, in fact, there are some areas I see hopefully will allow some additional transparency at least in some steps of the process that right now at least I assume were not open to public review so to the extent that that happens and to the extent that they are consistent in their responsibilities I see no problem with that happening. Want to give you a perspective though... on some of the problems that involves primarily CAFOs which I know has been listed as one of the areas to be covered by the Idaho Department of Environmental Quality. On the Home Place, not my place first let me say there are I think 3 or 4 large dairies within a two-mile radius of us we have never had any problems with them, never any problems with our ground water and they have been great neighbors. The Home Place at 3 south and 3 and a half west is a different matter at the location for several years their lagoon would overflow and actually run the (unintelligible) pit down three quarters of a mile and across and over into the pasture in what was the Home Place where I grew up. Now, that came to the attention of the Idaho Dairy Association and I think they brought that to the attention of the Idaho Department of Ag and this year as far to by knowledge it hasn't reoccurred. But, what has occurred is contamination of the ground water wells within an area of about 2 miles of the Home Place. To the extent that numerous well came up with Coliform contamination and nitrate levels have been recorded between 15 to 19 parts per million in the groundwater in that particular area, now as you know 10 ppm is at the level at which it becomes dangerous to children and pregnant women. Well anyway the response has been tepid at least because of the I don't know what you call it, "chimney effect" where everybody has their "we look at it from our perspective" and if it does not fit within that "chimney" you can go to somewhere else and pretty soon you're just in a total circle of 3 to 4 states and county agencies no one will take responsibility. It is my contention that the reason that the contamination is occurring is that in an attempt to avoid sanction by the state or Federal government for discharge of





products, you know manure and so forth from those lagoons by one reason or another whether intentional or unintentional those products are going down into our aquifer and contaminating out aquifer and that is unacceptable, Now I know the regulations are written again to compartmentalize the responsibility in these areas and basically we haven't found anybody that is willing or able to step up to the plate to even identify where the contamination is coming. Now, this certainly is not my area of expertise, but it is my understanding that either by the type of nitrates that they find in the contamination and/or by the analysis of the organic materials that they find in contamination that they can at least identify general perimeters as far as where contamination products are coming from, that's a start, I mean if we knew that then you would know whether it is something they are trying to avoid your rules by discharging again by intentional or unintentional means, if it unintentional it just a matter that their lagoons are not adequately lined, hey that is situation that can be corrected. If intentional which occasionally occurs that's again a situation. Anyway, I guess going back to bottom line, I certainly do not oppose and would encourage the transfer, but I think we have some work to do because that aquifer is something we don't want to lose. Thank you.






