- EPA is planning a minor model update: MOVES2014b



### **MOVES Minor Update: MOVES2014b**

- EPA is planning a minor MOVES update MOVES2014b that will improve the nonroad capabilities of MOVES
- MOVES2014b will include new nonroad engine population growth factors and will resolve a bug in the nonroad fuel supply. It will also update emissions for Tier 4 nonroad engines.
- This minor update will not impact inventories of onroad criteria pollutants
- MOVES2014b will not be considered a new model for SIP and transportation conformity purposes
  - There will be no new conformity grace period
- Estimated net emission changes between MOVES2014a and MOVES2014b will be shared with the Work Group as they become available
- Our target for releasing MOVES2014b is summer 2018
