Dear Mayor Pérez Heredia:

This letter acknowledges that the Municipality of Utuado (Municipality) has submitted a complete Notice of Intent (NOI) document to be covered under the National Pollutant Discharge Elimination System (NPDES) General Permit for Stormwater Discharges from Small Municipal Separate Storm Sewer Systems (Small MS4 GP) in urbanized areas (PRR040000) in Puerto Rico. Coverage under this general permit began at the conclusion of the Municipality's thirty (30) day waiting period, which is **July 2, 2021.**

The eligibility for coverage under the Small MS4 GP is based on the validity of the certification you provided on the NOI. Your signature certifies that you have read, understood and are implementing all of the applicable requirements of the Small MS GP. An important aspect of this certification requires that you correctly determine whether you are eligible for coverage under this Small MS4 GP.

In addition, the Small MS4 General Permit requires existing permittees to revise and update the current municipal Stormwater Management Program (SWMP) for the Municipality and begin implementing it. The modified SWMP must be submitted to the undersigned attention, one (1) year from the date of authorization of coverage under this general permit, by **July 2, 2022**. The Small MS GP outlines important measurable goals, storm sewer system mapping, detection and addressing non-storm water discharges, inspections and record keeping requirements, among others.
