PETITION FOR REVIEW

In accordance with Clean Air Act Section 307(b)(1), 42 U.S.C. §7607(b)(1), the Administrative Procedure Act, 5 U.S.C. §702, and Federal Rule of Appellate Procedure 15, NACCO Natural Resources Corporation and Mississippi Lignite Mining Company¹ petition for review of the U.S. Environmental Protection Agency's ("EPA") action promulgating a Federal Implementation Plan ("FIP") for Mississippi regarding

¹ On June 21, 2022, The North American Coal Corporation submitted comments on behalf of Mississippi Lignite Mining Company related to the EPA's Federal Implementation Plan addressing regional zone transport for the 2015 Ozone National Ambient Air Quality Standard.

Subsequent to these comments, The North American Coal Corporation changed its name to NACCO Natural Resources Corporation. Pursuant to an internal reorganization implemented on June 30, 2023, NACCO Natural Resources Corporation (f/k/a The North American Coal Corporation) assigned its 25% interest in MLMC to North American Coal, LLC, a Nevada limited liability company that is wholly owned by NACCO Natural Resources Corporation (f/k/a as The North American Coal Corporation). As a result, North American Coal, LLC owns a 25% interest in MLMC, while Red Hills Property Company, L.L.C. owns the remaining 75% interest in MLMC. Red Hills Property Company, L.L.C. is wholly owned by North American Coal, LLC.

Mississippi's interstate-transport requirements under 42 U.S.C. §7410(a)(2)(D)(i)(I) for the 2015 8-hour ozone national ambient air quality standards ("NAAQS"). This final EPA action is included in the notice entitled "Federal 'Good Neighbor Plan' for the 2015 8-Hour Ozone National Ambient Air Quality Standards, 88 Fed. Reg. 36,654 (June 5, 2023). See Fed. R. App. P. 15(a)(2)(C) ("The petition must ... specify the order or part thereof to be reviewed.").

Jurisdiction and venue for this petition are proper in this Court under 42 U.S.C. \$7607(b)(1). The agency action being challenged by NACCO Natural Resources Corporation and Mississippi Lignite Mining Company is the FIP for Mississippi, a "locally or regionally applicable" action which is not "based on a determination of nationwide scope or effect." *See* 42 U.S.C. \$7607(b)(1); *Texas v. EPA*, 829 F.3d 405, 418-24 (5th Cir. 2016). This petition for review is timely filed within 60 days of the date of publication in the Federal Register. A copy of the Federal Register notice containing the final action is attached in accordance with Fifth Circuit Rule 15.1(b).
