## PROTECTIVE PETITION FOR REVIEW

Pursuant to Section 307(b)(1) of the Clean Air Act, 42 U.S.C. § 7607(b)(1), and Federal Rule of Appellate Procedure 15(a), Petitioner Union Electric Co. d/b/a Ameren Missouri hereby petitions the United States Court of Appeals for the District of Columbia Circuit for review of the final action by Respondent United States Environmental Protection Agency entitled "Federal 'Good Neighbor Plan' for the 2015 Ozone National Ambient Air Quality Standards," published at 88 Fed. Reg. 36,654 (June 6, 2023) ("Final Rule"), a copy of which is attached hereto. This Court has jurisdiction over this Petition under 42 U.S.C. § 7607(b)(1). However, because the Final Rule is a "locally or regionally applicable" action and is not "based on a determination of nationwide scope or effect," the United States Court of Appeals for the Eighth Circuit is the proper venue. 42 U.S.C. § 7607(b)(1); *Tex. Mun. Power Agency v. EPA*, 89 F.3d 858, 867 (D.C. Cir. 1996) (Section 7607(b)(1)'s circuit-selection provision prescribes venue). Accordingly, Petitioner has a pending petition for review in the Eighth Circuit. The Petition filed in this Court is filed solely to preserve Petitioner's rights should venue be deemed improper in the Eighth Circuit.
