PETITION FOR REVIEW

Pursuant to Rule 15(a) of the Federal Rules of Appellate Procedure and Section 307(b) of the Clean Air Act, 42 U.S.C. § 7607(b), Petitioner Cross Oil Refining & Marketing, Inc. hereby petitions the United States Court of Appeals for the District of Columbia Circuit for review of a final agency action of the United States Environmental Protection Agency, titled "July 2023 Denial of Petitions for RFS Small Refinery Exemptions" (EPA-420-R-23-007) and published in the Federal Register on July 20, 2023 at 88 Fed. Reg. 46795 (July 20, 2023). See Attachment A. This petition is timely because it has been filed within sixty days of publication of the agency action.

EPA contends that this Court is the proper venue for this action pursuant to 42 U.S.C. § 7607(b)(1). Petitioner contends that 42 U.S.C. § 7607(b)(1) dictates that a challenge to a denial of its hardship petition must be filed in the regional circuit in which Petitioner is located. Accordingly, Petitioner has filed

its challenge to that denial in the United States Court of Appeals for the Eighth Circuit.

Petitioner recognizes, however, that in ongoing litigation related to the April and June 2022 denials that EPA has moved not merely to transfer challenges filed in regional circuits, but to dismiss them altogether.

Accordingly, Petitioner files this "protective petition" for review filed out of an abundance of caution to preserve Petitioner's rights. *See N.Y. Republican State Comm. V. S.E.C.*, 799 F.3d 1126, 1134-35 (D.C. Cir. 2015) (instructing petitioners to file "a protective petition" if "any doubt as to the proper forum exists.").
