3. Numpwen epwe wesino, ia EPA epwe watiw ekkoch sain ika esisin non ewe nen.

- Ekkewe chon angang rese tongeni angang non ekkoch ekkewe nenni mei annengaw, enukkungaw ika aweires, me efeiengaw. Ekkei nenni epwapw worr angangen non ewe Phase 2. EPA esapw angang oon ekkei nenni.

- **Mark MT mei pwech:** Ekkewe kanteiner mei nomwitiw nge neoneon kewe ra emwekuttu.
- **Painit mei Parr:** Ekkewe lenien chachii ika fifi mei nomw on nepenien ekkewe imw.
- **Painit mei pink:** Ekkewe mettoch mei worr asbestos non nge epwe nap seni esopw arr repwe amwokuttu iwa epwe emwekkut non ewe Phase 2.
- **Painit mei Orench:** Nenien kotturunoon kitten konik ren imwen ngaaseno ika sopw, ika metoch mei witiwiit ngeni ekkewe chon angang ngeni ekkewe pisek mei efeiengaw.
- **Equal sauin (=) mei Orench** on **ekkewe iirra** ina essisiinen efeiengau fansoun pechekunen asepwan.
- **Orench X** on Irra -- Irra mei efeiengau, kopwe towaw seni.
- **Orench arrow** (↑) ika esisin mei maketiw won irra, Tumunoch ren panen irra.
- **Araw finaik-** Tumunoch non ekewe neni mei eucha ngeni an ekewe aramas eoreni.
