President of the Arizona State Senate Warren Petersen, Speaker of the Arizona House of Representatives Ben Toma, and the Arizona Trucking Association petition this Court for review of the final agency action of the U.S. Environmental Protection Agency and Administrator Michael S. Regan, “Multi-Pollutant Emissions Standards for Model Years 2027 and Later Light-Duty and Medium-Duty Vehicles,” published on April 18, 2024 at 89 Fed. Reg. 27,842. The final rule exceeds EPA’s statutory

authority and is arbitrary, capricious, an abuse of discretion, and otherwise not in accordance with law. Petitioners respectfully request that this Court declare EPA's final action unlawful and vacate it.

This petition is filed in this Court in accordance with 42 U.S.C. § 7607(b)(1), Federal Rule of Appellate Procedure 15(a), and D.C. Circuit Rule 15(a). EPA's action is attached to this petition.
