PETITION FOR REVIEW

Pursuant to Section 307 of the Clean Air Act, 42 U.S.C. § 7607, 5 U.S.C. §§ 701-706, and Rule 15 of the Federal Rules of Appellate Procedure, Petitioner United States Steel Corporation ("U. S. Steel") hereby petitions this Court for review of the final action of the United States Environmental Protection Agency and Michael S. Regan in his official capacity as Administrator, entitled "National Emission Standards for Hazardous Air Pollutants: Taconite Iron Ore Processing," which was published in the *Federal Register* at 89 Fed. Reg. 16,408 (March 6, 2024) ("Rule"). The Rule imposes emission standards and other requirements on taconite iron ore processing facilities under EPA's authority to regulate hazardous air pollutants under 42 U.S.C. § 7412 and to amend existing hazardous air

pollutant requirements under 42 U.S.C. § 7412(d)(6). A copy of the Rule is attached as Exhibit A.

This petition is timely filed within 60 days from the date notice of promulgation of the Rule was published in the Federal Register.

This Court has jurisdiction and is the proper venue for this action because the Rule is "locally or regionally applicable" under 42 U.S.C. § 7607(b)(1). It applies only to the taconite iron ore processing facilities, which are few and are located in only two States (Minnesota and Michigan) within the same region.
