SOLICITATION OF VIEWS

The U.S. Environmental Protection Agency, Region 6 is preparing NEPA documentation for the proposed project, "Port Fourchon Marsh Creation Project," (TE-0171) under the authority of the Coastal Wetlands Planning, Protection and Restoration Act (CWPPRA). By this Solicitation of Views (SOV) notice, EPA is requesting your views and comments on any potential economic, social, or environmental adverse or beneficial impacts in the area of this project.

The TE-0171 project is located in the Terrebonne Basin, west of Belle Pass and Port Fourchon in Lafourche Parish, Louisiana. The Port Fourchon Marsh Creation project area is within the Timbalier Bay along the southeastern edge, bounded on the south by a barrier shoreline of beach, dune and marsh habitat, previously restored by a CWPPRA-funded project, and bounded on the west and north by Timbalier Bay and on the east by wetlands from another CWPPRA-funded project. Marsh creation and nourishment in this area will contribute to coastal wetland buffers protecting Port Fourchon from storm surge and will regenerate habitat for fish and wildlife. The project originally included a larger marsh creation and nourishment acreage (see attached factsheet) which was recently decreased after the 30% design by approximately ten percent (10%) to reduce project costs. As currently designed, the project will create and nourish approximately five hundred and forty-three (543) acres of coastal estuarine marsh by hydraulically dredging sediment from the Belle Pass federal navigation channel (see attached map). The project's design was funded by the CWPPRA Task Force. The project team plans to request construction funding from the CWPPRA Task Force in January 2025. If approved, construction is estimated to start late 2026 or early 2027.

Dear Ms. Bauschlicher: Although the referenced project is not in Terrebonne Parish, it is in the Terrebonne Basin and, under the circumstances, is extremely beneficial to Terrebonne Parish. The importance of this project to Terrebonne Parish is that we have five CWPPRA marsh creation/ridge restoration projects that were about to go to bid or were close to that point which have been seriously delayed due to the inability to acquire land rights. As a result, CWPPRA has placed three of these on its Critical Watch List. I expect the other two will be added to that list soon. Terrebonne needs marsh creation projects under construction and TE-0171 will certainly help our situation. I followed Dr. Taylor's presentation and spoke in favor of this project at the CWPPRA Task Force meeting on October 3, 2024, at USACE/NOD. **RE: PORT FOURCHON MARSH CREATION PROJECT (TE-0171)
SOLICITATION OF VIEWS RESPONSE**

Dear Dr. Taylor:

The Edward Wisner Trust Management Board (Wisner) owns property adjacent to the proposed project and supports construction of the Port Fourchon Marsh Creation project. Wisner leases much of the area adjacent to the project to the Greater Lafourche Port Commission for Port Fourchon.

If this project is not constructed and the area continues to erode, Bayou Lafourche will become a part of Terrebonne Bay and then the Gulf of Mexico. Each strong weather event – it no longer needs to be a hurricane – removes more of this barrier headland, and further endangers Wisner's revenues.

Any incursion will place billions of dollars of energy infrastructure at risk. Between 18-20% of the nation's oil and gas supply comes through this area. As Port Fourchon begins to develop the Fourchon Island to enlarge its capacity to service energy production in the Gulf of Mexico, it will have to incorporate more costly mitigation efforts to harden its facilities. Those costs will be passed along to consumers, further burdening individuals' pockets already battered by higher inflation rates and higher energy prices over the past few years.

This remnant headland is important, not just for protecting Lafourche Parish's economic engine, but also for protecting the cultural heritage of its residents. Seafood and its capture are tightly woven into the culture of south Louisiana. The mangroves that populate the marshes provide homes for species of concern and nurseries for shrimp, crabs, and fish. The bounty that makes Louisiana the Sportsman's Paradise is born in areas such as this. There will be substantial losses incurred in both the recreational and commercial fishing industries statewide and in the culture of Terrebonne and Lafourche Parishes if this area is not restored.

The Caminada Headland Beach and Dune Restoration Project, Increments I and II (BA-45 & BA-143), and the Caminada Headland Back Barrier Marsh Creation Project (BA-171) have shored up the eastern side of Bayou Lafourche. The West Belle Pass Headland Restoration Project (TE-52) has rebuilt the shoreline. The West Fourchon Marsh Creation Project (TE-134) restored the marsh behind the western bank of Bayou Lafourche and added storm protection. The Port Fourchon Marsh Creation Project (TE-0171) extends the lives of both TE-52 and TE-134. Also, TE-0171 will give TE-52 a marsh platform onto which it can roll – keeping the valuable sand in the system – and it will reinforce TE-134.

Wisner embraces using dredge material from Belle Pass to construct this project. The beneficial use allows the State, which has a multitude of restoration demands, to conserve other valuable sediment sources so that more of those needs can be met.

Over 60% of Wisner's revenues are returned to the community. If the land goes, Wisner's revenue, and our beneficiaries' ability to help the community as they have since 1914, goes. Wisner is grateful for the attention to the Fourchon area and respectfully asks that this project be submitted to CWPPRA for Phase 2 construction funding consideration.
