Tribal Water and Natural Resources Conservation – Assistance Program Inventory

A supplement to the Tribal Water and Natural Resources Conservation Guide: Federal Funding and Technical Assistance for Tribal Environmental Programs

Introduction: This inventory was compiled to help environmental program managers and staff working within federally recognized Tribal governments connect with federal resources that can support their work. More than 160 funding programs are featured in the *Tribal Water and Natural Resources Conservation – Assistance Program Inventory*. These programs were gathered using publicly available information and represent the best information available at the time. For the most up-to-date information, please visit the federal program websites, www.Grants.gov or www.SAM.gov. You should also reach out to the contact for each federal program for more details about the program, including eligibility, matching requirements and application dates.

How to use this inventory: You may search this static PDF version of the Program Inventory using keywords (CTRL F), and you may print this information on standard letter-sized paper. This PDF version is sorted by Agency, Bureau, and then Program Name. Data for all fields and cells are displayed. Use the Zoom-in feature to see the content more clearly. Field headings include conservation topic areas, whether it's open only to Tribes, Assistance Listing #, Agency, Bureau, program name, assistance type, eligible applicants, competitive/non-competitive, and matching requirements). *Note:* To filter results via the dropdown filters on the column headings, use the downloadable spreadsheet version of the inventory available on the website.

Definitions:

- (1) Tribe-only programs include those open only to Tribes and the programs with a predetermined dedicated amount of funds reserved, or "set aside," for Tribes.
- (2) Assistance listing # refers to the numbers are assigned to federal programs that provide grants, loans and other types of assistance awards. For more information, see: https://sam.gov/assistance-listings

Conservation topic areas: Each of the programs in this inventory is identified as primarily addressing one or more of the six conservation topic areas:

- 1. Protecting and Restoring Waters: Resources that help protect freshwater and coastal/marine water quality and quantity.
- 2. Protecting Air Quality: Resources that help protect air quality and reduce the associated health and water pollution problems.
- 3. Protecting Wildlife and Habitat: Resources that help ensure healthy wildlife.
- 4. Preparing for Climate Change and Other Natural Hazards: Resources that can increase Tribes' resiliency to climate change and associated natural hazards, such as flood, drought and fire.
- **5. Stewarding Lands:** Resources that help ensure healthy lands (agricultural, forested and urban lands).
- 6. Supporting and Engaging Communities: Resources that help enhance Tribal communities' connection to environmental resources, natural places and each other.
